In this connection, I am to point out that according to clause (iv) of the mortgage deed executed by them, if there whall be any breach by the mortgagor of the covenants on his part contained in the mortgage or if the mortgagor shall become insolvent or shall cease to be in service for any reasons or if he dies before all the dues payable to the mortgagee under these presents together with interest thereon shall have been fully paid off or if the said advance or have been fully paid off or if the said advance or any part thereof becomes payable forthwith under these presents or otherwise then and in any of such cases it shall be lawful for the mortgagee to sell the mortgaged property or any part thereof either together or in parcels and either by public auction or by private contract.
