ORDER:

In the G.O.read above orders were issued indicating the rates of weekly special allowance in lieu of daily allowance admissible to our station participants who undergo Training programmes sponsored by the training division, Department of Personnel & Administrative Reforms, Government of India in the Training Institute listed therein.

2. The Government of India have revised the rates of weekly special allowance in lieu of daily allowance in respect of certain training institutions.

3. Government now direct that special allowance in lieu of daily allowance be paid to the State Government participants as indicated in the annexure to this order.

4. The rest of Special Allowance is subject to the following conditions:

- i) The weekly special allowance in lieu of daily allowance is payable only in respect of courses sponsored by the Training Division, Department of P.A.R Government of India.
- ii) The participants should actually stay in Hostels in which accommodation is arranged by the Government of India as part of course arrangement or in the Hostels of the respective Training Institutions.
- iii) The Special Allowance will be admissible only to outstation participants who avail of the boarding and lodging facilities provided by the respective Institutions.
- iv) Participants who make their own arrangements for stay etc. will be allowed daily allowance only under the normal rules.

v) The participants who are sanctioned the Special allowance will not be eligible to draw the Special Training Allowance and daily allowances at one fourth rate sanctioned in G.O.Ms.No.3990, Public (Trg.) dated 25-10-1972.

5. This order supersedes the previous orders issued in this regard.

6. This order issues with the concurrence of Finance Department - Vice its U.O.No.20226/All.II/84-1, dated 25.2.84
