

ABSTRACT

Part II Scheme- 2009-2010 – Construction of Office building for Regional Director of Municipal Administration at Madurai and Tirunelveli – Sanction of Rs.120.00 lakhs- (Rupees One hundred and Twenty lakhs only) – Orders – Issued.

ORDER:

The Director of Municipal Administration in his letter read above has stated that there are seven Regional Directorates at Chengalpattu, Tiruppur, Salem, Vellore, Thanjavur, Madurai and Tirunelveli functioning under the Directorate of Municipal Administration. Out of this, only Vellore and Salem Regional Offices are functioning in their own buildings. The Regional Director of Municipal Administration offices at Tirunelveli and Madurai are housed in shopping complex and the Corporation office respectively. Hence, during the year 2009-2010, it is proposed to construct office buildings for Tirunelveli and Madurai Regional Directorates of Municipal Administrations at an estimated cost of Rs.150.00 lakhs (Rupees one hundred and fifty lakhs only) for each Regional Directorate of Municipal Administrations. The Director of Municipal Administration has therefore requested the Government to allot Rs.300.00 lakhs (Rupees Three hundred lakhs only) for this purpose under part–II Scheme for the year 2009-2010.

2) The Government after careful examination of proposal in para 1 above have decided to restrict the capital cost of the scheme to Rs.120.00 lakhs (Rupees one hundred and twenty lakhs only) ie Rs.60.00 lakhs (Rupees Sixty lakhs only) for construction of office buildings to each Regional Directorate of Municipal Administrations at Madurai and Tirunelveli and accordingly sanction is accorded. 3) The amount sanctioned in para 2 above shall be debited to the following head of account:

"2217 – Urban Development - 05 – other Urban Development Schemes 191 – Assistance to Municipal Corporations - Schemes in the Eleventh Five Year Plan II – State Plan – JY – Construction of Office Buildings - Regional Director of Municipal Administration at Tirunelveli and Madurai 09 – Grants – in – aid 02 – Grants for capital Expenditure (DPC 2217 05 191 JY 0920"

- 4) The Director of Municipal Administration is authorized to draw the amount sanctioned in para 2 above and disburse it to both the Regional Directorates of Municipal Administration at Madurai and Tirunelveli. The Director of Municipal Administration is requested to ensure that the new office buildings should be constructed within the financial year 2009-10 and he is also directed to send the Completion report to the Government.
