Order:-

The Government approve the proposal for construction of hostel buildings for trainees in Tamil Nadu Institute of Urban Studies, Coimbatore and quarters for staff of that institute at a total estimated cost of Rs.14.50 lakhs (Rupees fourteen lakhs and fifty thousand only) in the land in T.S.Nos.118 and 121 at Alagesan Road, Coimbatore, which has been leased out by Coimbatore Corporation to the Institute.

2. The Government sanction the payment of Rs.5/- lakhs (Rupees five lakhs only) as grant towards the cost of construction sanctioned in paragraph 1 above. The balance of cost of construction shall be met from special contributions to be paid to the Institute by the Municipal Councils, Township Committees and Corporations of Madras, Madurai and Coimbatore.

3. As the Tamil Nadu Institute of Urban Studies, Coimbatore functions for the benefit of all Municipal Councils, Township Committees and Corporations, the Government hereby direct them to pay a special contribution to Tamil Nadu Institute of Urban Studies, Coimbatore during 1984-85 at the rate of annual contribution ordered in G.O.Ms.No.1950, Rural Development and Local Administration Department, dated 24.11.81 towards the balance of cost of construction, as mentioned in paragraph 2 above, to the institute in addition to their usual annual contribution.

4. The Director, Tamil Nadu Institute of Urban Studies, Coimbatore shall draw the sum of Rs.5/- lakhs sanctioned in paragraph 2 above just before depositing the cost of construction with Public Works Department to which the work should be entrusted as a deposit work.

General Assistance to Corporation, Municipalities etc. Schemes in the Sixth Five Year Plan - II State Plan - JU. Assistance to Tamil Nadu Institute of Urban Studies, Coimbatore - 09. Grants-in-aid - D.P. Code 284 A ABJU 0902.

6. The Director, Tamil Nadu Institute of Urban Studies, Coimbatore is requested to report to Government the date of drawal of the sum of Rs.5 lakhs.
