ORDER:

The Director of Municipal Administration in his letter read above has stated that in order to provide uninterrupted power supply for improving water supply in the 11 financially weaker Municipalities, during the year 2009-2010, it is proposed to purchase generator sets at the total cost of Rs.100.00 lakhs (Rupees One Hundred Lakhs only). As the financial position of the following 11 Municipalities is weak, the Director of Municipal Administration has requested approval for this scheme under Part II scheme for the year 2009-2010 and requested to allot an amount of Rs.100.00 lakhs (Rupees One Hundred Lakhs only) in the Budget for the year 2009-2010 for the purchase of generator sets for those Municipalities.
