## GOVERNMENT OF TAMIL NADU **ABSTRACT**

Covernment Servants Conduct Rules - Transaction with Chit Fund Companies - Further instructions - Issued.

ORDER:

In the Government Order cited the Government have ordered that when a Government servant joins a Chit, the annual subscription of which exceeds Rs.1,000-00, he should report the fact to the Prescribed authority under Rule 7 of the Government Servants Conduct Rules. Further if he joins the Chit conducted by a Chit Fund Company with which he is having Official dealings, prior permission of the Prescribed authority should be obtained before joining the Chit. It was also ordered therein that if he receives the prize amount exceeding its.1,000-00 at the last instalment, he should report the fact to the Prescribed authority. If he receives prize amount in other instalment Prescribed authority. If he receives prize amount in other instalment which involved liability to pay future subscription, he should obtain prior permission of the prescribed authority.

- 2. In his letter cited, the Special Officer, Chit Corporation has stated that there was no Chit Fund Company in the Public Sector Mixim when the orders were issued in the Government Order referred to above. The Chit Corporation of Tamil Madu Limited, Madras is an undertaking of the Ocvernment of Tamil Nadu. The main object of the Chit Corporation of Tamil Nadu Limited in floating these chits is to cater to the needs of the salaried class and more particularly to the needs of the Government servants. He has stated that due to misgivings or with a view to avoid the trouble of having communication with the higher ups in the matter, some Covernment servants do not have transactions with the Chit Funds. He has, therefore, requested exemption of the Government servants having transactions with the Chi Corporation of Tamil Nadu Limited from the operation of the above Government Order as it may so a long way in making effective effort to enroll them as subscribers of the Chits floated by the Chit Corporation.
  - 3. The Government have examined the request of the Special Officer, Chit Corporation of Tamil Nadu and direct that Government servants having transactions with Chit Corporation of Tamil Nadu Limited be exempted from the operation of the orders issued in the Government Order cited.
  - 4. The Departments of Secretariat and the Heads of Departments are requested to communicate the above instructions to officers and staff concerned.
