The Office of the Town Planning, Madras was reorganised and four Regional Offices at Madras, Coimbatore, Tiruchirapalli, and Tirunelveli were set up, besides the Headquarters office at Madras. Again the Town Planning Department was reorganised on broader scale setting up eight Regional Offices at different places. Consequent on the reorganisations, the Director of Town Planning donsidered that certain powers vested in the Director of Town Planning, the Joint Director of Town Planning and the Personal Assistant to the Director of Town Planning under different statutes and orders, might be delegated to the Deputy Directors of Town Planning (Regional) to be exercised within their respective regional jurisdiction. The Government accepted the suggestions of the Director of Town Planning for delegating certain functions to the Regional Deputy Directors. for delegating certain functions to the Regional Deputy Directors.

Accordingly orders were issued in the G.O. read above, empawering the Director of Town Planning to delegate such powers to Regional Deputy Directors to be exercised within their respective jurisdiction.

However, no specific nevers to inspect the Town Planning. However, no specific powers to inspect the Town Planning Section of the Municipalities within their jurisdiction have been delegated to the Regional Deputy Directors. The Director of Town Planning has now requested to issue orders authorising specifically the Director of Town Planning, Joint Director of Town Planning and Deputy Director (Regional) concerned to conduct inspections etc., in respect of Town Planning section of municipalities. accept the proposal of the Director of Town Planning.

2. In partial modification of the orders issued in para 2 of G.O.Ms. No.142, Rural Development and Local Administration, dated the 2nd February, 1970, the Gov rnment of Tamil Nadu hereby authorises under sub-section(1) of section 38 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Director of Town Planning and Joint Director of Town Planning in respect of all those municipalities in the State and Deputy Directors in respect of conduct inspections, enquirits, etc. in respective jurisdiction to of the Town Planning section of Municipalities and also to have access to or call for records, reports, etc., pertaining to the Dished under the said Act.
