ORDER:

In G.O. (Ms) No. 566, RD& LA, detedl3-3-1962, certain cottage Industries have been permitted in notified residential areas, under the provise to clause (a) of section 92 of the Madras Public Health Act, 1939. A question was arisen, whether the cottage Industries permitted in G.Q.(Ms)No.566 RD & LA., dated 13-3-1962 can be set up in 'residential areas' has not be defined either in the die Madras Town Planning Act 1920 or in the Madras District Municipalities Act 1920. Under section 144 of the Madras Public Health Act 1939 (Madras Act III of 1939) if any provision relating to public health contained in any other enactment in force in the state of Madras is repugnent to any provision contained in the Act the latter provision shall prevail and the former provision shall to the extent of the repugnancy be void. The executive authories of Municipal Councils are informed that as such the terms residential areas or 'residential purposes' in the Town Planning Schemes will be construed to have the same definition and meaning as residential areas in the Madras Public Health Act and that the cottage Industries specified in G.O.(Ms)566.L.A., dated 13-3-62 will be permitted in the residential areas under Town Planning Schemes.
