1. Tenders for the execution of the above works (as detailed in the tender schedule and specification) in the City of Chennai will be received on behalf of the Commissioner, Corporation of Chennai by the Superintending Engineer / Electrical, Electrical Department at his office at Ripon Buildings, Park Town, Chennai upto 3.00 P.M. on the due date mentioned.
2. Printed forms of tender and contract together with drawings can be obtained from the Tender sales counter, Ripon Buildings, Chennai Corporation against payment of the amount specified, in the form of Bank Draft. This amount will not be refunded.
3. The work to be tendered for include all associated works. Connected with the above mentioned works, as specified in the specification and also subject to the terms and conditions contained in the contract. Decision of the Superintending Engineer / Electrical, will be final in case of any dispute regarding the nature of work to be carried out.
4. The tenderer shall carefully inspect the entire route and alignment of road for Lamp post installation/cable laying and shall inspect the Corporation Building in case of Electrification for this contract before tendering for the work so as to get an idea as possible of the extent of any implications involved in the work comprised in the contract.
5. The tenderer has to fill in the letter of tender and bills of quantities, must sign and deliver them back to the Superintending Engineer / Electrical, Electrical Department, Corporation of Chennai at his office at Ripon Buildings, Park Town, Chennai-600 003, in a sealed cover, superscribing the work, due date of opening reference number for which quoted and.
6. Tenderer shall furnish their tender along with the EMD in wax sealed cover for the contract value upto Rupees Twenty Five Lakhs. If the contract value more than Rupees Twenty Five Lakhs, the tenderer shall furnish their tender in three cover system. That is, one cover containing the tender and another cover containing the EMD, both these cover placed inside the third sealed outer cover with the subscription of Tendered work, due date of opening time etc. shall be addressed to the Superintending Engineer / Electrical, Corporation of Chennai, Chennai - 600 003, and delivered at Tender Sales Counter, Ripon Buildings on or before the due date of opening before 3 p.m. The tenders will be opened at the Ripon Buildings, Corporation of Chennai at 3.15 p.m. on the due date of opening. Belated offers will not be considered. Every tender must be accompanied by EMD at 1% of the contract value by the way of BankDraft payable at Chennai. Cash or Cheque or Tenders without required EMD will not considered.
7. No alteration whatever may be made in the text of the tender any remarks or explanations should be sent but in the covering letter. The form of contract is bound up with the other documents so that the tenderers may know that their liabilities and duties are and the entire tender form should be submitted to the Corporation when submitting the tender.
8. Attention is drawn to the Security Deposit, normally upto 2% (but which will be vary depends upon the lower percentage as mentioned in their Terms and conditions enclosed herewith) of the contract value which will have to be deposited by successful tenderer and to his having to execute agreement attached

within the time stated in the letter of tender. The Corporation will not accept letters authorising the Corporation to adjust amounts payable towards tender deposit as security deposit from pending bill of the tenderer.

9. The tender deposit of each unsuccessful tenderer will be returned to him as soon as possible after the final disposal of the tender. Deposit of the successful tenders will be returned to him after he has deposited the security deposit and execute the agreement, if that is done within the required time.
10. The successful tenderer will have to pay all stamp charges on the contractor.
11. Should the successful tenderer fail to furnish such security to execute the contract within the time specified for that purpose in the tender or to furnish the income tax clearance certificate while execution of agreement, he shall forfeit his tender deposit to the Corporation and concluded contract will in such case be considered as having been rejected abandoned and the Commissioner of the Corporation of Chennai shall there upon be at such time or times in such manner and on such terms as he may think it to arrange for the performance of the work departmentally or be any other person or persons and the defaulting tenders shall be held liable irrespective of the forfeit of aforesaid for all damages losses costs, charges and expenses arising from or by reason of such failure and arrangements. The acceptance of the tenderer by the Corporation shall be deemed to result in and constitute a valid and concluded contract binding on the tenderer not withstanding the non-execution of the contract agreement.
12. It must be clearly understand that the prices quoted in the tender are to include everything required to be done by conditions of contract and specifications or by any drawing therein referred to and also all such works as are necessary for the proper completion of the contract through special mention thereof may have been omitted in the specifications or drawings.
13. No allowance shall be claimed by or made to the contractors whose tender may be accepted for any error in rates of whatsoever description that may be discovered after his tender is sent in.
14. The Corporation does not bind itself to accept the lowest or any tender or to adhere to the quantities specified and may reject and or all or the tenders received without assigning any reasons or more items of work without assigning any reasons.
15. The successful tenderer will not be exempted from the payment of any municipal rates, tolls or taxes in consequence of his being contractor for the Corporation.
16. Any further information that may be required may be obtained from Electrical Department, Corporation of Chennai, on any working day between 10.00 a.m. and 5.30. p.m.
17. The tenders shall be opened for acceptance for a period of 90 days from the last date fixed for the receipt of tender. If there is no mention about validity period in the tender, it will be construed that the quoted rate are valid for 90 days.
18. Tenderers are referred to the description of work given in the accompanying specification which is to be read as part of the Bill of quantities. The rates and prices given in the bills of quantities are to cover all the works and detailed

described in the specification or shown in the drawings and it is to be strictly understood that no claim will be entertained which is based on the circumstances that works may be described in the specification to which apparently no corresponding items is given in the bills of quantities.

19. The tenderers or their agents are expected to be present at the time of opening tenders. The Tender receiving Officer will open each tender, prepare a statement of the attested and unattested corrections therein and if any of the tenderers or their agents find unattested corrections and communicate it to him. The absence tenderers shall then accept the statement of the corrections without any question whatsoever.
20. 2% plus 12% surcharge on I.T. and 2% Education cess M.I.T and S.C. on Income tax deduction will be made by the department from the work bill value during the payment to the contractor for crediting in the accounts of Central Government as per section 1940 of Income Tax Act 1961.
21. 5% retention amount from the work bill value will be withheld for release with security deposit soon after satisfaction of entire work execution.
22. Post offers will not be considered.
23. The rates shall be quoted both in words and figures.
24. The tenders should be sent in wax sealed covers only.
25. Every Tenderer is requested fully pre-receipt the enclosed E.M.D. refund order form by affixing a Rs.1/- revenue stamp at the appropriate place and signing over it under official seal for arranging refund of E.M.D. in the case of successful contractor E.M.D. will be refunded on execution of agreement and payment of security deposit.
26. The bank draft for EMD shall be drawn in favour the Commissioner, Corporation of Chennai.
27. The security deposit shall be furnished by the successful tenderer in the shape of National Small Savings Scripts / Certificates and have to be pledged in favour of the Commissioner, Corporation of Chennai.
28. Tenders received from such registered contractors registered for electrical work in Electrical Department under appropriate class only will be considered.
29. In the event of an order placed on successful contractor, the MANUAL WORKERS GENERAL WELFARE FUND at 0.3% of the sanctioned estimate amount will be deducted at the time of presenting the contractor first bill as per the Tamil Nadu Manual Workers (Regulation of employment and conditions of work) Act 1982 vide Corporation of Chennai Finance Cell circular No. FC No.889 / 2006 dt : 12-9-2006
30. INDEMNITY BOND : In the event of an order placed, the successful contractor has to be executed by the contractor indemnifying the Corporation of Chennai from any claim which may arise due to any accident to the workers engaged for the work or other damages.

Whereas the contract has agreed to execute work for the department mentioned in
the specification and schedule attached conditions hereinafter mentioned and whereas
the contractor has deposited with the purchaser the following securities.

Now these present witness that for carrying the said agreement in this behalf into
execution,the contractor and the department to hereby mutually covenant, declare,
contract and following(that is to say).

The terms (contract) shall include these presents and the Tender Schedules and
specification hereto annexed and the specifications, plans and drawings herein and

hereinafter.

The Term Contractor shall mean the persons, firm or company with whom the order for the work is placed and shall be deemed to include the contractor's successors (if approved by the department) representatives, heirs, executors and administrators unless excluded by the contractor.

The terms "Corporation" shall mean the "Commissioner" or the Council of the Municipal Corporation of the City of Chennai or both acting under the powers vested in them by the Madras City Municipal Act IV of 1910 or any act amending or altering the same.

The terms "Commissioner" shall mean the Commissioner of the Corporation.

The term "Electrical Engineer" shall mean the Electrical Engineer of the Corporation of Chennai for the time being.

TERMS AND CONDITIONS OF THIS CONTRACT

1. The Contractor shall execute the work specified herein.
2. The Electrical Engineer shall be the sole judge upon all matters relating to the meaning and consequence of the specification and conditions of this contract.
3. The materials shall be of the very best quality and shall comply with the conditions and stipulations specified herein. All the materials taken from the contractor shall be inspected by an officer of the Electrical Department not below the rank of an Assistant Divisional Electrical Engineer and the decision of the Electrical Engineer as to quality shall be final and binding on both parties.
4. Time shall be considered as the absence of this contract on the part of the contractor and in case the contractor shall fail to complete the work under this contract within the time specified or within the time to which the period of completion may have been extended under the powers herein given, or if in the opinion of the Electrical Engineer the Contractor shall not be carrying out work at such a rate as will ensure completion of work within the time given, it shall be lawful for the Commissioner of the Corporation of Chennai without prejudice to his remedy contained in clause 10 to obtain the un-executed portion of the work from any other person or persons and any additional expense so incurred shall be payable by the Contractor.
5. If at any time during the continuance of this agreement the contractor shall in the opinion of the Electrical Engineer have been delayed in execution any work ordered by reason of any lockouts strikes, riots, mutinies, wars, fire, storms, tempest or other un-expected exceptional causes, the time for execution may be extended by the Electrical Engineer as he may consider reasonable.

6. All expenses, damages and other moneys payable to the Corporation by the Contractor under any stipulations in this contract may be retained out of any moneys then due to which may subsequently become due from the Corporation to the Contractor under this or any other contract and in case such moneys then due or to become due to the contractor by the Corporation shall be insufficient to pay such said expenses, damages and moneys it shall be lawful for the Commissioner of the Corporation to sell and dispose of any or all of the securities deposited by the contractor and out of proceeds of such sale to reimburse and pay to the department all the said expenses, damages and moneys and in case such proceeds of sale of the said securities shall be insufficient, then it shall also be lawful for the department to recover the residue of the said expenses, damages and moneys, if necessary by legal proceedings against the contract.

7. The Contractor shall submit bills to the Electrical Engineer for payments and when the Electrical Engineer shall direct.

8. The Contractor shall be paid for the work at the rates given herein on certificates of the Electrical Engineer that the work have been executed to his entire satisfaction.

9. The contract shall not be assignable by the Contractor.

10. In case the contractor shall fail or neglect or refuse to observe, perform, fulfill and keep all or any one or more or any part of any one or more of the covenants, stipulations and provisions herein contained it shall be lawful for the Commissioner of the Corporation of Chennai without prejudice and in addition to all the any every other of the remedies herein before contained on behalf of the department on any such failure neglect or refusal as aforesaid by writing under his hand to put an end of this agreement and on the expiry of seven days from the date of service of the said writing this agreement shall cease and be void except in respect of any prior action or omission.

11. Penalty Clause : If the contractor fails to complete the work within the specified period, penalty will be imposed at the rate of 0.1% of the contract value of such portion of work which have not been executed on the specified period for each day of delay and such penalty shall not exceed 5% of the contract value in any case.

12. All certificates or notices of orders for time or for extra varied or altered works which are to be the subject of an extra or varied charge whether so described in the contractor or not shall be in writing and unless in writing shall not be valid or binding or be any effect whatsoever.

13. Retention Amount : at 5% of the work bill value will be withheld to return along with the security deposit, after satisfactory completion and handing over the entire work.

GENERAL CONDITIONS OF THE CONTRACT :

1 (a) The work should be commenced within 7 days of awarding the contract and after execution of necessary agreement and after be completed within a reasonable period. Once the work is commenced there should not be stoppage of work except for weekly off and other reasons beyond his control.

(b) The service of the contract should be available in demand at any time of day on holidays or working days.

2. The work should be carried out strictly according to the specification.

3. In case of abnormal delay in executing the work and also not doing the work according to the specification the Commissioner, Corporation of Chennai reserves the right to terminate the agreement and to take up the work either departmentally or through some other agencies. He will also have the right of the reduce the rate of this discretion, if the standard specification of worth has not been followed by the contractor.

4. The responsibility of accident to any employees of the contractor will only rest with him. The contractor should also execute an indemnify bond on stamp paper indemnifying the department from the liability for any accident to the man employed by the contractor and also damaged caused to other services such as P & T cables, street light cables, sewerage mains and water mains of chennai corporation and M.E.S. cables TNEB.

5. The contractor shall be held responsible for the loss or damages to the department materials tools and plants etc. during the execution of the works and the cost of such loss or damages will be recovered from the contractor.

6. The work will be carried out under the immediate supervision of the staff of our department not below the rank Junior Engineer.

7. The contractor shall acknowledge the receipt of various materials handedover to him by this department at the time of transporting from stores etc., it is responsibility of the contractor to provide watch and ward staff for the materials transported and handed over to the contractor will the work is completed in all respects.

8. The entire route of the proposed erection of street lamp posts and proposed cable laying work will be given to the contractor and treated as site for all purpose.

9. The contractor should make his own arrangements for providing red flags during daytime with caution boards and danger lights during night to the satisfaction of the trafficdepartment.

10. The contractor will be held responsible in case of any theft or loss at the site or during transport by the contractor including departmental supply of materials.

11. The contractor will be authorized and deputed their supervisors and present at the time of executed work at site.

12. This department will get clearance from the various other departments for cutting the roads / streets / pavement surface. The contractor shall be responsible for causing unnecessary damages and cuts on the roads / streets / pavement surface.

TERMS AND CONDITIONS :

1. Rate shall be quoted both in WORDS & FIGURE

2. If difference between words and figures rate, the lower rate will only be taken into consideration.

3. An Insurance Policy, shall be taken to cover Workmen Compensation ACT

4. An Indemnity Bond shall be executed by the successful contractor indemnifying the corporation of chennai from any claim which may arise due to any accident to the workmen engaged for the work or other damages.

5. Execution period : **FOUR MONTHS**

6. Departmental supply of materials : necessary fittings

7. Contractor supply of materials : All other materials required for the work shall be supplied and utilised by the contractor except departmental supply of materials.

8. Sample : A sample tin of paint to be used for the painting of lamp post shall be produced to the concerned Asst. Divisional Engineer and to get approval before execution of agreement.

9. Agreement : Shall be executed by the successful contractor within 7 days on receipt of contractor work order along with 2% security deposit.

10. Manual Workers General Welfare Fund : In the event of an order placed, the successful contractor has to pay 0.3% of the sanctioned estimated cost.

11. Security deposit : In the event of an order placed, the successful contractor has to pay an amount at 2% of the order value in the form of NSC / Scripts and pledged in favour of Commissioner, Corporation of Chennai.

12. Income tax Deduction : at 2% plus 12% S.C. on IT and 2% Education cess on I. T. and S.C will be deducted from the work bill value for crediting into the Central Govt.

13. Ladder for painting of street lamp post shall be contractor responsibility.

14. Transportation : Carting of all the materials required for the work shall be of contractor responsibility.

15. Penalty Clause : If the contractor fails to complete the work within specified period, penalty will be imposed at the rate 0.1% of the contract value of such portion

of work which have not been executed on the specified period for each day of delay and such penalty shall not exceed 5% of the contract value in any case.

16. Sale tax deduction : at 4% will be made by the department from the work bill value during the payment to the contractor for crediting into the A/c. of Assessing Officer concerned under 7F for deduction of Tax at source TNGST Act 1959 and Tamilnadu Act 15 of 1999.

17. Retention Amount : at 5% from the work bill value will be with held for release with security deposit soon after satisfaction of entire work.

18. Payment : Will be made after completion of work as per the measurement recorded in our departmental M' Book.

19. B' Grade Contractor's Licence : In original issued by the Electrical Inspector, to Govt. Govt. of Tamilnadu shall be produced the Asst. Divisional Engineer, concerned before commencing the work for verification

20. Execution of work : After execution of agreement, the successful contractor has to be contacted the concerned ADE of this department. The materials for the work to be supplied / utilised only after ascertaining by the concerned ADE of this department.

21. For Electrification work, the work shall be carried out in accordance with the PWD standard. The materials such as PVC pipes, PVC wires of all sizes, U. G. Cable, 5 Amp / 15 Amp switches, 5 Amp / 15 Amp switch controlled socket, D. P. / TPIC switches of all ratings, ceiling fans etc. shall be supplied and utilised by the contractor with ISI mark.

All other materials which are not bearing ISI mark should be got approved by the B concerned ADE of this department before commencement of work.

22. Rates should be quoted both in words and figures : If difference between words and figures rate, the lower rate only will be taken into consideration.

23. Everyday after completion of work, the excavated earth and debris have to be removed from the road / platform portion by the contractor and dumped in a place with concurrence of the site Engineer.

24. Carting of all the materials required for the work including departmental supply of all the materials shall be of contractor's responsibility.

25. Depending on the site condition, contractor will be informed that they may have to execute the work during restricted hours.

26. The contractor is solely responsible for the safety of all the materials before or after installation including departmental supply of materials. Only after handing over of the installation in a proper manner, the Corporation will take the responsible. If any

dispute arises in this regard, the decision of Superintending Engineer / Electrical will be final.

27. "No Advance Payment will be made"

28. Excise duty, Sales Tax etc. shall be clearly indicated in the offer. If there is no mentioned all out excise duty and Sales Tax the same will be construed that the rate quoted are inclusive of Excise duties, sales tax etc.

29. For supply portion 80% payment will be made after supply and acceptance of the materials and Balance 20% will be made only after completion of work.

30. For supply of cables by the contractor, sample bit of cable has to be tested at Electrical Department, Corporation of Chennai by our cable testing equipment. The supply of cables will be accepted only after receipt of satisfactory test report.

31. If the total amount offered by the contractor is lesser than departmental contract value mentioned in the Tender Notice, the following additional security deposit should be paid and enclosed along with the tender in the form of demand draft drawn in favour of the Commissioner, Corporation of Chennai. The tender without such additional security deposit will be summarily rejected.

1. No additional security deposit need to be paid if the contractor tender amount is lesser than below 5%

2. If the contractor tender amount is lesser than 5% to 15% ,

The additional security deposit at 2% of the departmental total contract value should be paid along with the tender.

3. If the contractor tender amount is lesser than 15% to 20% and above ;

The additional security deposit should be paid along with the tender for 50% of the difference between total departmental contract value and the contractor tender amount.

32. Excavation of L.T cable Trench of size 45 cm wide and 75 cm deep shall be made in all kind of soil . The trench shall be straight and fall in line with the contour of the road or street. If the cable could not be laid 75 cm deep , payment will be made on prorata basis.
