Namakku Naame Thittam – Guidelines issued for the implementation of the scheme – Minimum Public contribution for Scheduled Castes/Scheduled Tribes areas to be 1/5th – Amendment – Issued.

ORDER:

The Hon'ble Chief Minister, among others, has made the following announcement on the Floor of the Tamil Nadu Legislative Assembly on 07.01.2022, while replying to the debate on the Governor's address:

"நமக்கு நாமே திட்டத்தின் கீழ் உள்ள மூன்றில் ஒரு பங்கு மக்களுடைய பங்கு என்பதை பட்டியலின மற்றும் பழங்குடியின மக்களுக்கு ஐந்தில் ஒரு பங்கு என விதிகள் தளர்த்தப்படும்"

2. Based on the above announcement of the Hon'ble Chief Minister, the Director of Municipal Administration in his proposal second read above, has conveyed that in urban areas in the habitations of Scheduled Castes/Scheduled Tribes, the minimum public contribution of the estimate value of the work may be amended as 1/5th of the project cost, so that, more people from the Scheduled Castes/Scheduled Tribes habitations will be encouraged to participate in improving the infrastructure in their locality. The Director of Municipal Administration has therefore requested the Government to suitably amend the scheme guidelines issued in the Government order first read above, so as to allow 1/5th (one fifth) of the project cost as minimum public contribution for any identified work under 'Namakku Naame Thittam (Urban)' in areas of Corporations and Municipalities, where the Scheduled Castes/Scheduled Tribes population is high.

3. The Government after careful examination of the proposal of the Director of Municipal Administration has decided to accept the same and accordingly order that for any work identified under 'Namakku Naame Thittam (Urban)' in areas of town panchayats, municipalities and municipal corporations, where the Scheduled Castes/Scheduled Tribes population is high i.e. more than 50 (fifty) percentage to the total population that particular area, the minimum public contribution shall be 1/5th (one-fifth) of the estimated value of the work. In every town panchayat, municipality and municipal corporation, the executive officer/ commissioner has to identify such areas and justify the request while sending the proposals. Consequently, the following amendment is issued to the guidelines of the scheme prescribed vide the Government order first read above:

AMENDMENT.

For the existing para 1 of the Guidelines of Namakku Naame Thittam (Urban), viz "1. Public Participation" issued in G.O.(Ms) No.71, Municipal Administration and Water Supply Department, dated 13.09.2021, the following para shall be substituted:

"1. Public Participation:

- (i) The minimum public contribution for any of the identified work should be one third of the estimate value.
- (ii) In respect of the works related to renovation of water bodies, the minimum public contribution should be 50% for the desilting and bund formation component. For other components like pathway, retaining wall, light / bench facilities etc., the minimum public contribution will be one third of estimate value.
- (iii) In respect of areas, where the Scheduled Castes/Scheduled Tribes population is more than 50 (fifty) percentage to the total population of that particular area, the minimum public contribution shall be one fifth of the estimate value of the work. In every town panchayat, municipality and municipal corporation, the executive officer/ commissioner has to identify such areas and justify the request while sending the proposals".
- (iv) There will be no upper limit for public contribution

4. This order issues with the concurrence of Finance Department vide its U.O. No.19201/Finance(MAWS)/2023, dated 05.05.2023.


